LOCAL LAW NO. 1 (INTRO #1) 2016 FOR ENACTING AN AMENDMENT TO SECTION C-70 (M) OF THE TROY CITY CHARTER.

BE IT ENACTED, by the City Council of the City of Troy, as follows:

SECTION 1: §70 (M) of the Troy City Charter shall be amended.

SECTION 2: § 70 (M) of the City Charter, as amended, shall provide the following:

M. Transfer of funds. The City Council shall approve any transfers or appropriations of \$500 or more not specifically authorized in the budget. Upon written request of the Mayor and any department, division or bureau head, the City Council may approve the transfer of an unencumbered balance in an appropriation from any department, division or bureau to another department, division or bureau. For purposes of this section, a transfer shall include any shift of funds from one account to another, whether or not the funds are to be returned to the original account. Any transfer of funds from the water fund or sewer fund to any other department, division, bureau, or the general fund shall require a two thirds vote of the City Council. Additionally, any such legislation shall not be acted upon it shall be the subject of at least one public hearing by the council upon five days of public notice.

SECTION 3: Pursuant to § C-37 of the Troy City Charter, a Local Law amending the Charter shall not be acted upon by the City Council until it shall have been the subject of at least three public hearings after introduction unless such requirement is waived by a resolution of the Council adopted by a unanimous vote.

SECTION 4: The three public hearings required by § C-37 shall be scheduled as follows: Wednesday, April 20th, 2016 at 5:30 p.m.; Thursday, April 28th, 2016 at 6:00p.m. and Thursday, May 5th, 2016 at 6:00 p.m.

SECTION 5: This act shall be effective immediately.

LOCAL LAW #1

Memo in Support

Over three fiscal years, 2012-2014, the water fund was depleted by \$6,416,000 to cover up deficits in the general fund. This local law will improve budgeting practices throughout the year. These transfers from the water fund took necessary money from the fund that could and should have been used for capital improvements to the city's water system.

This legislation is intended to preserve and protect our very important water system. This legislation will require that before any money is transferred out of the water or sewer fund a public hearing will be required. This legislation will create a more open and transparent process for future non-budget transfers which were made out of the water and sewer fund.

Additionally, this legislation requires a two-thirds vote of the city council to transfer money out of the water and sewer fund. This will make it more difficult to transfer these monies and deplete our water and sewer funds.

This local law may be amended to conform with the new city charter, which is to take effect July 1, 2016.

Fiscal Impact: To help prevent certain future transfers from the water and sewer fund that have occurred over the last several years.

**ORDINANCE AMENDING THE 2016 CITY BUDGET TO ACCEPT FUNDS FROM
THE NEW YORK STATE OFFICE OF PARKS, RECREATION AND HISTORICAL
PRESERVATION FOR THE TROY URBAN PARK**

The City of Troy convened; in City Council, ordains as follows:

Section 1. The City of Troy is hereby authorized and directed to accept funds from the New York State Office of Parks, Recreation and Historic Preservation in accordance with the provisions of Title 9 of the Environmental Protection Act of 1993 or Recreational Trails Program), in the amount not to exceed \$ 48,480.00, and enter into and execute a project agreement with the State for such financial assistance to the City of Troy for the Troy Urban Park and if appropriate, a conservation/preservation covenant to deed of the assisted property.

Section 2. The City of Troy 2016 budget is herein amended as set forth in Schedule A entitled:

Environmental Protection Fund Municipal Grant Program

which is attached hereto and made a part hereof

Section 2. This act will take effect immediately.

**ORDINANCE DECLARING CERTAIN CITY OWNED PROPERTY AS SURPLUS

Section 1. Pursuant to C-73 (A) of the City Charter, the item of City owned property, described in the attached memorandum is herein declared to be surplus and the City Purchasing Agent or a designee, is hereby authorized and directed to sell all said property.

Section 2. The said property shall be sold "as is" for the highest bid price and on such additional terms and conditions as shall be set by the City Comptroller.

Section 3. If no bidder or bidders are interested in any or all of said property, the City Comptroller is hereby authorized to dispose of any such item.

Section 4. This ordinance shall take effect immediately.

Inter-Office Memorandum

Per our conversation regarding the dental equipment that the City of Troy is paying Arnoff Moving and Storage to store, I wanted to give you a timeline of the events leading up to the move. It has been quite a lengthy process:

On September 3, 2015 the City of Troy foreclosed on 205 5th Ave in Lansingburgh. The property had been a dental office for many years prior. The last dentist to occupy the property left every bit of the practice behind when he closed the doors. All the furniture, equipment, and miscellaneous items were left untouched for 3 years, until the City took possession.

After conferring with several City Department Heads, any items that were usable throughout the City were delivered to many different departments. Chairs and a fax machine went to the Assessor's Office, file cabinets to the City Clerk and Mayor, and an assortment of office furniture went to the Police Department. The remaining items were of no use to the City whatsoever.

At that point it was decided to check into the value, if any, of the items left. The City Assessor contacted Atlas Resell Management and they gave a quote for a consignment buy-out of \$4,485.00 for 14 items. The remainder would most likely be disposed of. Atlas Resell is based in Idaho, so they contacted a local dealer James Corkran to ship the items. However, James decided he would like to purchase the items as well and consign them locally. The City Assessor approached the City Comptroller and they decided to have the items all deemed surplus property by the City Council in order to facilitate a sale or consignment. The City Comptroller prepared legislation for the November Finance Meeting and subsequent December Council meeting to declare the items surplus. However, the City Council refused to declare the equipment surplus without a complete inventory, and tabled the legislation on 12/3/15.

In the meantime, the new owner wished to close on the property quickly as it needed to be secured and heated for the upcoming winter. On 11/20/15, the closing took place with a signed agreement between her and the City Attorney that the equipment would be left untouched until the proper arrangements for removal could be made.

On December 16, 2015 I met with Randy Passonno from Collar City Auctions. The Comptroller's Office wanted his expert opinion that the equipment would be worth auctioning. Randy thought there would be some

value to the equipment, so we decided to proceed. The Comptroller's Office released a Request for Proposal for Auctioneer Services, and Collar City Auctions was the only company to respond. Randy would take all the items to his warehouse, do a complete inventory, and hold the auction. It was recommended that Randy be awarded the contract.

Also on December 16, 2015 we met with John Gebbert from Schapp Moving and Storage. John would charge \$1,990.00 to box and move the items, and the monthly storage fee would be \$300.00. They could not give us a concrete moving date until late January so we decided to get another quote from Arnoff Moving and Storage. We met with Todd Stromberg on January 8, 2016. They could complete the move the following Wednesday, and the charge would be \$1,920.00 with the first month's storage included. Each additional month would be \$100.00.

Wednesday, January 13, 2016 the movers from Arnoff bagged, boxed, and loaded the items from the property and delivered them to their warehouse in Albany for safe storage. That is where the items are today.

The Comptroller's Office respectfully requests the City Clerk's Office review this document and the attached pictures with the Council President. The City cannot remove the items from storage and deliver them to the Auctioneer until the property is deemed surplus. The previous Council did not want to declare surplus without a full inventory being done. Unfortunately, the Purchasing Agent and the movers were not dental equipment experts, and could only compile a very preliminary inventory. However, we do have the original quote from Atlas Resell that listed the items he was going to consign, which represents some of the bigger ticket items. As you can see from the pictures, there is much more to be sorted through that may be of value.

Time is of the essence in this matter as we are still paying \$100.00 per month to Arnoff for storage. This charge will diminish the profits we stand to make once the items are set up for auction. Once the items are delivered to the Auctioneer he will have a full inventory done, and will make that information readily available to the City Comptroller and the City Council. Randy has done many auctions for the City in the past, as is always very professional. I have the utmost confidence that he will deliver

Date: April 11, 2016

The Capital Plan for 2016 has been adjusted since the proposed plan in August of 2015. There are five categories in the Capital Plan for the Department. Below is an explanation of the plan and the need for the adjustment.

Transmission Main Improvement Program:

Due to a large water main break in January 2016 it is required to replace approximately 3,700 feet of 33" line with 36" line. This will increase volume of flow and allow for alternative service locations for wholesale customers. The project has been submitted to New York State Environmental Facilities Corporation (EFC) for financing. A Grant has also been submitted that would allow up to 80% of the cost to be funded.

In order to complete the project by the end of December 2016 as stated in multiple timelines it is required to purchase material before any funding is available. Due to the timeframe of bidding, awarding and lead times on material it needs to be ordered before EFC funding is available. I propose using the water fund to initially purchase the materials. Once funding is available the water fund can be reimbursed for these costs. Materials including pipe, valves, and fittings are anticipated to cost 1.4 million dollars.

Dam Safety Program:

The Department of Environmental Conservation (DEC) has developed regulations regarding high hazard dams, to which the Tomhannock Dam, Wright Dam and Bradley Lake Dam are included in this. The Tomhannock Dam has recently been reconstructed to meet new guidelines. A new low level outlet is required, and anticipated to be included in the construction of the new transmission mains. Bradley and Wright Lake Dam also require work, the bulk of this work will be evaluation and investigation, and a more extensive construction phase will be developed for 2016- 2017.

Water Treatment Plant and Facilities Upgrade:

Over the past few years there have been many upgrades to the Water Treatment Plant (WTP). We have been working on replacing the sludge draw equipment that is original to the plant with new non metallic equipment that won't rust and or rot while in the water and need a total of eight sets to complete the upgrade. We have also replaced the roofs on

the administration and chemical feed room along with the fuel filling station at the DPU Shop. This included replacement of a bulk gas and diesel tank. As part of this project contamination was found from an old 5,000 gallon #6 Fuel oil tank and 500 gallon waste oil tank. These tanks have been removed and the contamination is now removed.

The proposed plan for 2016 is to finish projects ongoing from 2014. At Eddy Lane Pump Station a new chemical containment area for Hypo Chlorite will be constructed and an emissions filter will be installed on the diesel powered generator. The water plant will finish an upgrade to the SCADA system.

Vehicles:

In the past few years DPU has made many vehicle purchases. The original 2016 capital plan included two pickup trucks. The revised plan includes one dump truck, pipe inspection equipment and a vehicle for the mechanics with lift gate and utility box. As part of a required Asset Management Plan by the Department of Environmental Conservation, inspection equipment needs to be acquired by June 1, 2016. The proposed inspection equipment can satisfy this requirement and save the city costs of hiring an outside company for inspections.

Water System Improvements and GIS:

Due to the nature of the DPU business and the increasing requirements for safer drinking water, many water quality concerns are coming forefront in the department. These include the many contaminants that are required to be removed from the water and the control of the byproducts from treatment (THM's). It is an ever growing process to handle the requirements and necessary studies and treatment techniques to control byproducts. These studies are ongoing and will help develop the water system into the future to meet the standards and rules as set forth by the Department of Health.

At this time, through testing it is determined that water quality is satisfactory and we are moving forward with testing and evaluation of recoating the four water tanks that DPU owns and operates. Once the evaluation is complete we are expected to move on with coating in 2017-2018.

Conclusion:

The Department of Public Utilities has many ongoing and future projects that are required for many different reasons, regulatory, updating and continued service to the residents. Through these projects and efficient use of the water fund, the department will continue to supply safe reliable drinking water. 2016 is heavily focused on the 36" water line replacement, vehicle purchasing and completing outstanding projects from years past.

A 2016 projects cost was discussed with the Acting Comptroller and it was stated that the water fund had the available funds to cover such purchases.

Notice is hereby given that the City of Troy, New York hereby present its proposed 2016 One Year Action Plan budget (OYAP) for the 2016-2017 Consolidated Planning program year that begins July 1, 2016. Proposed U.S. Department of Housing and Urban Development funding includes \$1,645,167 Community Development Block Grant (CDBG) funding, \$148,644 Emergency Solution Grant (ESG) funding and \$465,965.60 HOME Investment Partnerships Program funding.

A statutory 30-day public comment period will begin on Thursday, **March 24, 2016** and ends on Monday, **April 25, 2016**. All residents, property owners, and other stakeholders of the City of Troy are encouraged to submit written comments or questions regarding the draft One Year Annual Action Plan to the Department of Housing & Community Development located at City Hall, 433 River Street Troy, NY 12180 or email to carolin.skriptshak@troyny.gov

In addition, a special public hearing by the Troy City Council will be held at City Hall, 433 River Street, Troy on **Thursday April 7, 2016 at 6:30 PM**. Troy stakeholder and city residents are encouraged to comment on the proposed 2016 Annual Action Plan budget. Final approval of the proposed 2016 One Year Annual Action Plan is scheduled for **Thursday, May 5, 2016 at 7:00 PM** the regularly scheduled Troy City Council meeting.

A copy of the Five Year Strategic Plan of the Consolidated Plan as well as the Annual Action Plan are available for public review weekdays between the hours of 8:30 AM to 4:30 PM at the offices of the Department of Housing and Community Development in Troy City Hall.

Funding is proposed for the following projects:

Planning & Administration (CDBG): \$ 295,167

CDBG Planning Administration (Troy Housing Department, \$295,167): Funding is for staff salaries, and to perform the administrative requirements of the Community Development Block Grant program as required under the regulatory statutes of the United States Department of Housing and Urban Development (U.S. Department of HUD).

Neighborhood Livability (CDBG): \$ 350,000

Code Enforcement (Troy Code Enforcement Department, \$ 275,000): funding to conduct code inspections and related program delivery work in low/moderate income census tract areas.

Recreation (City of Troy Recreation Department, \$75,000): Recreation improvement projects will consist of project based improvements at various park locations to improve safety conditions, access, and projects that expand recreational opportunities for City

residents.

Lansingburgh Target Area Reinvestment \$1,000,000:

Lansingburgh Target Area Reinvestment (City of Troy Housing Department, \$900,000):

The Lansingburgh Target Area will consist of targeted infrastructure improvements, and neighborhood quality of life improvements including, sidewalks and curbing replacement, milling & paving, streetscape improvements, public safety and neighborhood park improvements. 2nd Ave (110th S- 114th St.) and adjacent side streets, 111th Street Waterfront.

Program Delivery Expense (City of Troy Housing Department, \$100,000): Direct program expenses related to the Lansingburgh infrastructure project including onsite project management oversight, design and engineering, Davis Bacon compliance and related work and coordination with contractors and homeowners.

ESG Homelessness \$148,644

ESG Administration, (CARES, \$11,148.30): Administrative and related program expenses associated with the implementation of the Emergency Solutions Homeless Grant Program.

Unity House Emergency Shelter Operating Expense, (Unity House, \$30,560.00):

Emergency shelter operating funds: this service provides emergency shelter and support for domestic violence victims and their children who are faced with homelessness as a result of domestic violence.

Unity House Homeless Prevention, (Unity House, \$6,883.47): The Unity House Prevention program provides emergency rental assistance and security deposits for residents that are at risk of becoming homeless.

TAUM Furniture Program – Rapid Rehousing (Troy Area United Ministries, \$11,164.45): Provides free Furniture to households obtaining permanent housing after homelessness.

TAUM Furniture Program – Homeless Prevention (Troy Area United Ministries, \$3,106.91): Provides free Furniture to households obtaining permanent housing after homelessness.

Roarke Center Connections Homeless Prevention Program (Catholic Charities, \$11,347.08):

The Roake Center Prevention program provides case management and rental assistance for residents that are at risk of becoming homeless. As a means to keep residents from becoming homeless clients are provided on-going services related to education, rehabilitation, job search, mental health and maintaining permanent housing.

Joseph's House Emergency Shelter Operating Expense (Joseph's House, \$48,160.00): Operating funds: this service provides shelter and support, advocacy and re-housing services to City of Troy homeless residents.

YWCA Homeless Prevention (Troy YWCA, \$16,273.79): Program serves more than 50 homeless women and women with children to work towards becoming self sufficient.

Homelessness Planning and Assistance Services (Corporation for AIDS Research, Education and Services, Inc. (CARES), \$10,000): Funds to provide updates and maintenance of the Homeless Management Information Services System (HMIS) database required by United States Department of Housing and Urban Development (USDHUD).

(HOME) \$465,965.60

HOME Administration Costs (City of Troy, \$46,596.56): Perform the administrative requirements of the HOME program as requested by the City of Troy and by the United States Department of Housing and Urban Development (USHUD).

CHDO Set-Aside Project (TBD, \$169,369.04): A certified CHDO will undertake new construction projects or perform rehabilitation on city owned property that will be sold to low and moderate income persons either in the Troy Housing Authority's Self-Sufficiency program, the City's Homebuyer Incentive Program, or Habitat for Humanity homebuyers.

Homeowners Incentive Program (TRIP, \$250,000): Grants for City of Troy first time homebuyers. Grant provides down payments, closing costs, and mortgage reductions for low/moderate income first time homebuyers.

All Troy residents and taxpayers, as well as neighborhood organizations, businesses, and other stakeholders in Troy are invited to review this spending plan and comment on it in writing, until 4:30 PM on Monday April 25, 2016. After receipt of public comments from the April 7, 2016 public hearing, and 30-day public comment period the City Council will move to approve the One Year Annual Action Plan at its regular meeting at 7:00 PM on Thursday, May 5, 2016. Thereafter, the City of Troy will submit its formal application for funding to HUD by May 16, 2016.

This letter advises that the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) has reviewed and approves Phase II of the City of Troy's (Subgrantee) Hazard Mitigation Grant Program (HMGP) Application for Project # 4085-0011 (Project). The Phase II revisions made to the Scope of Work, Funding, and Work Schedule are authorized in order to accomplish Phase II Construction and Improvement Activities.

The Total Estimated Project Costs are not to exceed the revised amount of \$14,198,850 for both Phase I & Phase II of the Project. FEMA is now authorizing the remaining funding in an amount not to exceed \$12,871,850 Federal share at 100% under Global Match of the Phase II anticipated costs of construction. FEMA previously awarded \$1,327,000 Federal share at 100% under Global Match for the Phase I Project costs.

The Project location, existing conditions, and proposed scope of work are described below, along with the funding details, grant management requirements, and conditions of Approval. The New York State Division of Homeland Security and Emergency Services (NYS DHSES or Grantee) has primary responsibility for management of the Project and accountability of funds, as set forth in Title 44 of the Code of Federal Regulations (44 C.F.R.), Part 206, Subpart N and 44 C.F.R. Part 13.

I. Project Details

The Project's Scope of Work provides for the upgrade 7,750 linear feet of bulkhead wall. This upgrade will protect and mitigate the wall from potential breaches, will help to maintain the

structural integrity, and protect adjacent structures. Currently, the bulkhead wall is in poor condition. It exhibits varying degrees of deterioration; damage due to ice flows, high velocity flooding and damage from the impact of debris traveling downstream. The condition and age of the mass-concrete portions indicate that the life expectancy of the exposed and unprotected concrete has exceeded its useful life. The loss of significant sections has diminished the structural integrity of the bulkhead wall and continued deterioration will further decrease the factors-of-safety for resistance to sliding and overturning. The bulkhead wall must be protected for the future social and economic welfare of the City of Troy.

II. Project Funding and Grant Management Requirements

Funding for this sub-grant will be provided as follows:

Grant agreement articles of the FEMA-State Agreement govern this HMGP sub-grant, which incorporates the grant management requirements set forth in the 44 C.F.R. In accordance with 44 C.F.R. § 13.30(d), prior approval by FEMA is required for any revision to the scope or objectives of the Project, or extension to the Period of Performance. Any such request must be submitted to FEMA Region II, Mitigation Division, Sandy Grants Branch¹, prior to

implementation of the revision. Any change that does not receive prior approval from the NY SRO will violate the conditions of this sub-grant.

III. Phase II Conditions of Approval

Approval is contingent upon fulfillment of all of the following:

1. Project Completion Deadline

Based upon the information provided within the application, a Project completion deadline of February 25, 2019 has been established. The Project completion date includes sufficient time for NYS DHSES and the City of Troy to conclude its administrative contract requirements and considers potential delays resulting from weather conditions, and other unforeseen circumstances.

In order for the City of Troy to request an extension of the Period of Performance, NYS DHSES must submit a formal written request to the FEMA Regional Administrator. The request must be made no later than sixty (60) days prior to the expiration of the period of performance and must include a justification for the extension. This justification must demonstrate that construction work is in progress. Other information required with this request includes: a revised budget information form (regardless of whether there are changes to the budget), percentage of work completed and a description of all work completed.

2. Reporting Requirements

The Grantee is required to submit quarterly financial and performance reports within thirty (30) days after the end of each quarter in accordance with 44 C.F.R. § 13.40, 13.41, and 206.438(c). These reports should reflect the status and completion date for the Project. Any problems or circumstances affecting the completion date, scope of work, project cost, or which could be expected to result in noncompliance with the approved grant conditions are to be described in the quarterly progress reports. Requests for additional Project time extensions will only be considered in instances where the Subgrantee has provided the Grantee with accurate quarterly status reports.

3. Reimbursement of Allowable Costs

Once funding has been obligated, the Grantee is to submit a claim to the FEMA Region II, Mitigation Division, Sandy Grants Branch for reimbursement of allowable costs prior to drawing down those funds in accordance with 44 C.F.R. § 206.438(d). These submitted claims must also certify that reported costs were incurred in the performance of eligible work, that the approved scope of work was completed, and that the mitigation measure complies with the provisions of the FEMA-State Agreement.

4. Project Closeout

Upon completion of the Project, the Grantee must ensure that the sub-grant has been completed in compliance with the approved scope of work and with all required environmental conditions and all Hazard Mitigation Unified Assistance (HMA), National Flood Insurance Program (NFIP), and HMGP Guidance.

5. Other Regulatory Requirements

As part of the Approval, the Subgrantee is required to adhere to all applicable Federal laws, regulations, and policies

6. Technical Feasibility and Cost-effectiveness

The Phase I deliverables and responses to inquiries demonstrate that the project is technically feasible and cost-effective in accordance with the requirements of HMA Guidance, Part VIII, Additional Program Guidance: A.9 Phased Projects. Upon becoming aware of any changes to the planned work, changes in budget or schedule, or other federally-funded planned work which may overlap in planned work, the Grantee will promptly notify FEMA in order for FEMA to determine whether additional review is required to assure the project remains technically feasible and cost effective.

7. Environmental Requirement

a. Archaeology

If, during the course of work, archaeological artifacts (prehistoric or historic) or human remains are discovered, the Subgrantee shall stop work immediately in the vicinity of the discovery and notify the FEMA Region II, Mitigation Division, Sandy Grants Branch within 24 hours. The Subgrantee will ensure that archaeological discoveries are secured in place, that access to the sensitive area is restricted, and that all reasonable measures are taken to avoid further disturbance of the discoveries. In addition, if unmarked graves are present, the Subgrantee shall notify the local law enforcement agency within 24 hours of the discovery and the FEMA Region II, Mitigation Division, Sandy Grants Branch within 72 hours. Work in the vicinity of any discovery will not resume until the FEMA Region II, Mitigation Division, Sandy Grants Branch has completed consultation with State Historical Preservation Office, Tribes, and other consulting parties as necessary.

b. Permitting Requirement

The City of Troy shall obtain all federal, state, and/or local permits that are required. Prior to commencement of construction, the City of Troy must submit a copy of all permit applications and permits received to NYS DHSES. Permit applications and permits are to be reviewed and maintained by NYS DHSES to ensure compliance with the Project's approved scope of work. NYS DHSES is to provide copies of all permit applications and permits to FEMA Region II, Mitigation Division, Sandy Grants Branch prior to the City of Troy

initiating construction. Failure of the Subgrantee to obtain the required permits associated with the approved scope of work violates the condition of this project approval. This could result in a determination that no Federal funding is eligible to be reimbursed for this Project.

Note: Prior to the start of ground disturbing work, the City of Troy should have initiated permitting with the US Army Corp of Engineers (USACE), the New York State Department of Environmental Conservation (NYS DEC), the local floodplain administrator, and other permitting agencies with jurisdiction over the proposed Project. Should the City of Troy be advised of any problems or issues that have any bearing on the proposed design, they shall immediately notify NYS DHSES and FEMA Region II, Mitigation Division, Sandy Grants Branch.

c. Record of Environmental Consideration

A copy of FEMA's Record of Environmental Consideration (REC) is included, this summarizes the results of the environmental review, and outlines all the requirements and conditions of environmental and historic preservation compliance.

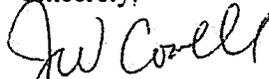
IV. Conclusion

Once the project is completed, the Subgrantee shall perform all necessary maintenance and annual inspections to ensure the structural stability of the project. Maintenance and inspections shall be documented and maintained by the Subgrantee, since this documentation would be essential in determining the eligibility of federal funding for any future damages occurring at the site.

FEMA urges your office to meet with this Subgrantee to review the Project requirements as soon as possible. At this meeting, please establish a follow-up schedule of Project monitoring including quarterly performance reporting and fiscal documentation requirements. Copies of all contracts entered into for this Project need to be provided to, and maintained by NYS DHSES. We are available to assist both NYS DHSES and the City of Troy in the implementation of this Project.

RESOLUTION OF CITY COUNCIL APPROVING HOME RULE MESSAGE REGARDING AMENDMENT OF PUBLIC OFFICERS LAW AND AUTHORIZING FORWARDING OF SAME TO NEW YORK STATE LEGISLATURE

WHEREAS, the New York State Public Officers Law contains certain provisions that exempt public officials in the City of Troy from the residency requirement set forth in Public Officers Law § 3(1); and

WHEREAS, it is the preference of the City Council that, where possible, public officials serving in the City government of Troy should be residents of the City; and

WHEREAS, Local Law 4 – 1984 which has been incorporated into the Troy City Code as Article IV, § 60-5 – § 60.7, with certain exceptions, sets forth a residency requirement for employees of the City of Troy; and

WHEREAS, the City Council desires that the NYS Public Officers Law be amended to remove the exemption of public officials in the City of Troy from the residency requirements of Public Officers Law § 3(1); and

WHEREAS, the City Council of Troy does not have the legislative authority to amend a State law as such an amendment must be enacted by the New York State Legislature; and

WHEREAS, the submission of a Home Rule Request to the State Legislature is a prerequisite to consideration by the State Legislature of such a requested amendment to the Public Officers Law;

WHEREAS, such a Home Rule Request must be supported by a two-thirds vote of the City Council.

NOW, THEREFORE, BE IT RESOLVED, that the attached Home Rule Request seeking to amend the Public Officers Law is hereby approved by the City Council; and

BE IT FURTHER RESOLVED, that the President of the City Council is authorized to forward the attached Home Rule Request to the State Legislature for its consideration.

MEMO IN SUPPORT

In July 1975, a home rule message submitted by the city of Troy amended NYS Public Officers Law to exempt appointed public officers in the City of Troy from having to be residents in the City of Troy. Normally, in most cities in New York State a public officer must be a resident of that community. The 1975 amendment was submitted by the city to allow a non-resident of Troy to become Corporation Counsel. Over the years, due to that local law, many key public officers in the city have been non-residents. This exemption does not serve the interest of our community, and we should require our public officers to be residents of Troy. The public officers hold key positions in the city, such as department heads and members of planning and zoning boards. It goes without saying that individuals holding these positions should live in the community to which they are making very important positions.

Since 1975, we have had such public officers as corporation counsel, comptroller, budget director, city engineer, and members of our planning and zoning boards who are not residents of Troy. It is in the interest of our city to eliminate this exemption of the Public Officers Law Section 30-6, and require appointed public officers to reside in our city.

It is noteworthy that in 1984, local law 4 of 1984, the city passed a local law requiring non-public officers (employees) to be residents of Troy. It certainly makes no sense to allow top policy makers in our city to be non-residents while the average city employee must be a resident.

This home rule message will help end this discriminatory practice.

While the city council strongly encourages police and firefighters to reside in our city, these employees are covered under a separate state law, and are not impacted by this home rule message.

HOME RULE REQUEST

(Request by a Local Government for Enactment of A Special Law)

To: New York State Legislature

Pursuant to Article IX of the State Constitution, the City of Troy requests the enactment of Senate/Assembly Bills No. ____/____ entitled:

An Act To Amend Public Officers Law Sec. 30 By Deleting Subsection 6 of Sec. 30 From the Public Officers Law.

It is hereby declared that a necessity exists for the enactment of such legislation and that the facts establishing such necessity are as follows:

1. This Home Rule Requests seeks the amendment of a State statute and the local government does not have the power to enact such legislation by local law.
2. Explanation: Public Officers Law Sec. 3 initially requires that in order to hold a civil office in a local government, such as a municipal corporation, a public officer must be a resident of the political subdivision or Municipal Corporation within which his/her official duties are required to be exercised. The basic concept was that it was generally desirable for public officials who were making decisions affecting citizens in a municipality to also reside in the community. Over time, however, a large number of exceptions to this rule were carved out on behalf of various public servants, including police and firefighters, to permit persons to provide municipal services who were not residents of the respective City, Town or Village. A number of such exceptions are contained in Sec. 30 of the Public Officers Law.

Public Officers Law Sec. 30(6) was enacted in 1975 at the request of the City of Troy at a time when one or more of the City's public officials was not a resident of the City. The language of this section provides an exemption from the City residency requirement for public officials provided that they reside in Rensselaer County. The one exception to this exemption was the City Manager, a position that was previously abolished and replaced with a strong Mayor form of government.

It is submitted that the exemption provided by Public Officers Law Sec. 30(6) potentially undercuts some of the benefits to be gained by requiring public officials in Troy to reside in the City. Sec. 30(6) also appears on its face to contradict subsequently enacted local legislation that set forth a City residency requirement for public officials serving in Troy. Local Law No.: 4 – 1984 which was enacted on December 18, 1984 provided such a residency requirement except for those persons expressly exempted by the Public Officers Law such as police officers and firefighters. This local law also recognized the potential difficulty of a relatively small municipality such as Troy in recruiting qualified public officers, particularly for positions requiring a professional license, certification, experience and /or particular training. This local law provides a waiver mechanism for the Mayor where he/she is unable to obtain a qualified candidate who is a resident of the City or willing to move to the City within a 90 day period. Local Law No.: 4 – 1984 is currently included as Article IV in the Troy City Code.

In view of the above discussion, it is respectfully requested that Public Officers Law Sec. 30 be amended by the removal of Subsection (6) from the statute.
