Brief Description of Proposed Action (include purpose or need): Project contemplates a historically sensitive adaptive renovation and reuse of the vacant former Troy Record building for operation as a mixed-use residential and retail building providing retail space and amenities on the ground floor with market rate apartments, as well as construction of a new 5 story building addition along Broadway and Sixth Avenue. Demolition of the circa 1980s press room addition would be a part of this project. The residential part of the buildings includes a total of 101 units (mix of studio/1BR/2BR/3BR) with the existing building renovation consisting of 25 units, and the new addition including an additional 76 residential units. The building design includes approximately 24 parking spaces on the first floor level, in addition to surface lot parking. The project proposes to infuse commercial spaces (restaurant/retail/office) into the building along the Broadway frontage.




