MAJOR AREA VARIANCE

ZB2010-016 Major Area Variance to allow for excessive signage related to a proposal to construct building identification signage at 1516 peoples Avenue, an R-1 Zone, ID101.48-5-1. Applicant is Duncan and Cahill for RPI, 11 Oakwood Avenue, Troy, New York, 12180.

ZB2010-017 Major Areas Variance to allow for front yard parking related to a proposal to construct a driveway at 302 Hoosick Street, a HCD Zone, ID 101.33-5-14. Applicant is Daria Robbins, 302 Hoosick Street, Troy, New York, 12180.

ZB2010-018 Major Area Variance to allow for excessive letter height related to a proposal to construct signage at 120 Hoosick Street, Subway, an HCD Zone, and ID101.31-10-3/1. Applicant is Ed Grennon, for Subway, 156 Hoosick Street, Troy, NY 12180.

ZB2010-019 Major Area variance to allow for excessive letter height related to a proposal to construct signage at 2 River Street, Old Brick Furniture, a B0-5 Zone, ID 100.76-9-24. Applicant is Hanley Signs for old Brick Co., 26 Sicker Rd, Latham, NY 12110.

ZB2010-020 Major Area variance to allow for a rear setback deficiency related to a proposal to construct a 3 season room at 15 Hyland Circle, a P Zone, ID 80.43-3-2.2. Applicant is Champion Windows for Gerald Gordon, 12 Jupiter Lane, Albany, NY 12205.

All projects are reviewed in accordance with the 2007 NYS Building Code, NYS Fire Code and all other applicable codes by The Bureau of Code Enforcement and Engineering. Further protocol will be addressed on a case by case basis during this review
