**ORD. #1
ORDINANCE AUTHORIZING AND APPROVING THE FILING
OF THE CITY OF TROY'S APPLICATION FOR FUNDING PURSUANT
TO THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974,
THE MCKINNEY ACT EMERGENCY SHELTER GRANT PROGRAM
AND THE HOME INVESTMENT PARTNERSHIP PROGRAM AND DESIGNATING
THE MAYOR AS THE AUTHORIZED
REPRESENTATIVE OF THE CITY FOR SUCH PURPOSES**

The City of Troy, in City Council, convened, ordains as follows:

Section 1. The City of Troy's consolidate plan grant funding for 2008-2009 program year is set forth in the notice of proposed project funding, identified as Schedule "A", which is attached hereto and made a part hereof. The Mayor on behalf of the City of Troy be and hereby is designated as the authorized representative of the City of Troy to act in connection with the filing of an application for funds pursuant to the United States Housing and Community Development Act of 1974 (CDBG), the McKinney Act Emergency Shelter Grant Program(ESG), and the HOME Investment Partnership Program (HOME).

Section 2. The Mayor, on behalf of the City of Troy, is hereby authorized to execute all contracts, documents, and other instruments in furtherance of implementing all projects associated with and described in such application and to use such funds pursuant to such Application and described in the attached Schedule "A" and undertake other such actions and provide such additional information as may be required in the furtherance thereof.

Section 3. This act will take effect immediately.
