Memorandum in Support

Geraldine FitzGerald is an active resident of the City of Troy, serving many years as the President of the Beman Park Neighborhood Association and as owner of Small World Property Rentals. Ms. FitzGerald desires to serve the City as a member of the Board of Assessment Review. Section 523 of the Real Property Tax Law requires each local government to have such a Board consisting of three to five members, who are appointed by the legislative body. Ms. FitzGerald's appointment will bring our Board into compliance with the law. Such appointments are required to be for five years, and this term will end September 30, 2013.
