WHEREAS, the City Council President called a special meeting of the City Council for December 1, 2009 for the purpose of adopting the City budget for fiscal year 2010.

NOW, THEREFORE, BE IT RESOLVED, that the recommended budget estimates, as modified by the attached Schedule "A" are adopted; and such estimates, as so adopted, shall become the budget estimates for the City of Troy for the year 2010.
