
1. ***(Previously tabled at the September 15, 2020 meeting)*** Consider the minutes of the August 24, 2020 special meeting. A motion was made by Commissioner Sullivan to table agenda item #1, seconded by, Chairperson Bill Rauh , all in favor 2-0, 1 absent.
2. **Consider the minutes of the September 15, 2020 meeting.** Following review, a motion was made by Commissioner Sullivan to approve the minutes of the September 15, 2020 meeting, seconded by Chairperson Bill Rauh, all voted in favor: 2-0, 1 absent.
3. **Consider an MSD-222 to establish one (1) position of City Comptroller. (COT)** Following review, Commissioner Sullivan made a motion to approve MSD-222 to establish one position of City Comptroller, seconded by Commissioner Rauh, all voted in favor: 2-0, 1 absent.
4. **Review the established Civil Service Exempt class position of City Comptroller.** A motion was made by Commissioner Sullivan to keep City Comptroller as an exempt class position, seconded by Commissioner Rauh, all voted in favor: 2-0, 1 absent.
5. **Establish a promotional eligible list for four (4) years for Assistant Code Inspector, Exam #74745.** Following review, a motion was made by Commissioner Sullivan to establish and approve the eligible list for four (4) years for Assistant Code Inspector, Exam #74745, seconded by, Chairperson Bill Rauh all voted in favor: 2-0, 1 absent.
6. **Establish an open competitive eligible list for four (4) years for Assistant Code Inspector, Exam #60083.** Following review, a motion was made by Commissioner Sullivan to establish an eligible list for four years for Assistant Code Inspector, Exam #60083, seconded by Commissioner Rauh, all voted in favor: 2-0.


