King Fuels Site

National Grid completed Phase I of their remediation of the site and continued to Phase II of the clean-up efforts getting the site closer to redevelopment.

Geothermal

The Troy LDC worked with the city to establish a Geothermal District located downtown. Major planning components of the project have been completed in 2024. The design of the loop has been drafted and is currently going through the SEQRA process.

Grants

Late in 2023, the City of Troy awarded Troy LDC \$1 Million in ARPA funds to create a Small Business Improvement 50/50 matching grant program throughout the city. In July of 2023, the program was kicked off. Throughout 2024 projects completed the work and sought reimbursement. At the end of 2024, 10 projects had been completed with \$385,110 in grant funds expended and a match investment by the business owners.
