Important Questions	Answers	Why This Matters:
What is the overall deductible?	\$0 individual/\$0 family in-network . \$200 individual/\$400 family out-of-network .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes. Emergency room care and emergency medical transportation services are covered before you meet your out-of-network deductible . Copayments and coinsurance amounts don't count toward the out-of-network deductible .	You will have to meet the deductible before the plan pays for any services. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . See a list of covered preventive services at https://www.healthcare.gov/coverage/preventive-care-benefits/ .
Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan?	\$6,350 individual/\$12,700 family in-network out-of-pocket limit . \$2,000 individual/\$4,000 family out-of-network .	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit?	In-network : Premiums , balance-billed charges, and health care this plan doesn't cover do not apply to your total maximum out-of-pocket. Out-of-network : premiums , balance-billed charges and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

Will you pay less if you use a in-network provider ?	Yes. See _____ or call _____ for a list of in-network providers .	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Be aware your in-network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services.
Do you need a referral to see a specialist ?	No.	You can see the specialist you choose without a referral .

Does this [plan](#) provide Minimum Essential Coverage? Yes.
