The Capital Resource Corporation (CRC) is authorized and empowered by Section 1411 of the Not-for-Profit Corporation Law of the State of New York to promote community and economic development and the creation of jobs in the non-profit sectors for the citizens of the City of Troy by developing and providing programs for not-for-profit institutions, manufacturing and industrial businesses and other entities to access low interest tax-exempt and non-tax-exempt financing for their eligible projects.

The CRC is further empowered to undertake projects and activities within the City for purposes of relieving and reducing unemployment, bettering and maintaining job opportunities, carrying on scientific research for the purpose of aiding the City by attracting new industry to the City or by encouraging the development of, or retention of, industry in the City.

RPI Series 2010 - Issued April 2010 in the amount of \$311,630,000. In 2020, this bond was refunded and currently shows a principal balance of \$261,165,000 remaining as of December 31, 2020.

RPI Series 2010 - Issued June 2010 in the amount of \$47,180,000 with a principal balance of \$2,680,000 remaining as of December 31, 2020.

RPI Series 2015 - Issued November 2015 in the amount of \$74,045,000 with

a principal balance of \$64,605,000 remaining as of December 31, 2020.

Operations and Accomplishments

The CRC contributed \$100,000 towards the Troy LDC's Franklin Alley Project. The project was made up of both public and private partners and helped to transform the space into an inviting pedestrian walkway.

The CRC awarded a grant to the City of Troy, N.Y for up to \$10,000 for the Neighborhood Improvement Program managed by the City Council.

The CRC sponsored The Powers Park Concert Series in the amount of \$5.000.

The CRC contributed \$20,000 to the Tech Valley Center of Gravity to be used for operating expenses related to their community access programs.

The CRC contributed \$60,000 towards COVID relief to downtown businesses (\$50,000) and businesses located outside of the downtown (\$10,000). The funding went towards creating safe, outdoor spaces to assist restaurants meet their patron restrictions and remain open.

The CRC established funding for The Riverwalk Trail Project. This consists of several key sites that will ultimately help to connect the different areas along the waterfront into one trail. The CRC has set aside \$50,000.
