Absent: Commissioner William Barhold.


Chairperson Sullivan called the meeting to order at 9:33 A.M.

1. **Consider the minutes of the January 18, 2022 meeting.** Following review, a motion was made by Commissioner Sullivan to table the minutes of the January 18, 2022 meeting, seconded by Commissioner Fogarty, all voted in favor: 2-0, 1-absent.
2. **Review and approve the Troy Civil Service Commission Annual Report for 2021.** Following review, a motion was made by Commissioner Sullivan to approve the Troy Civil Service Commission Annual Report for 2021, seconded by Commissioner Fogarty, all voted in favor: 2-0, 1 absent.
3. **Establish an open competitive eligible list for four (4) years for Secretary I, Exam #2201.** Following review, a motion was made by Commissioner Sullivan to establish the open competitive eligible list for four (4) years for Secretary I, Exam #2201, seconded by Commissioner Fogarty, all voted in favor: 2-0, 1-absent.
4. **Consider an MSD-222A to establish one (1) additional position of Laborer for the City of Troy Appointing Authority, General Services Unit.** Following review, a motion was made by Commissioner Sullivan to establish one (1) additional position of Laborer for the City of Troy Appointing Authority, General Services Unit, seconded by Commissioner Fogarty, all voted in favor: 2-0, 1-absent.
5. **Consider an MSD-222A to establish one (1) additional position of Recreation Maintenance Worker II for the City of Troy Appointing Authority, General Services Unit.** Following review, a motion was made by Commissioner Sullivan to establish one (1) additional position of Recreation Maintenance Worker II for the City of Troy Appointing Authority, General Services Unit, seconded by Commissioner Fogarty, all voted in favor: 2-0, 1-absent.
6. **Consider amending the Troy Civil Service Performance/Agility Test Policy.** Following discussion to reduce the period of restriction from 6 months to 4 months for unsuccessful candidates to be eligible to retake the performance/agility test, a motion was made by Commissioner Sullivan to approve the amendment to the Troy Civil Service Performance/Agility Test Policy, seconded by Commissioner Fogarty, all voted in favor: 2-0, 1 absent.

The next meeting is tentatively scheduled for March 15, 2022 at 9:30 A.M.


